PUBLIC NOTICE TO INTERESTED PERSONS HAVING THE RIGHT TO SIGN A REQUEST FOR PARTICIPATION IN A REFERENDUM

PUBLIC NOTICE TO INTERESTED PERSONS:

- Following the Public Consultation held on June 17th, 2024, at its regular meeting of July 8th, 2024, the Council adopted the Second Draft Resolution authorizing the construction of a dock under the By-Law 2022-008, respecting Specific Construction, Alteration or Occupancy Proposals for an Immovable (SCAOPI 2024-001);
- 2. The purpose of the Second Draft Resolution is to authorize the construction of a dock extending the limits of Lot 4 876 173 towards the shoreline, to a width of 4.88 metres for the last 3.05 metres of the dock instead of the maximum width of 1.8 metres prescribed in paragraph 3 of article 138 of the Zoning By-Law;
- 3. This provision may be the subject of an application by persons interested in Zone V-18 and contiguous Zones CONS-1, RU-2, RU-3, RU-4, RU-7, RU-8, RU-10 and V-22 to have the resolution submitted to persons qualified to vote for approval in accordance with the Act respecting elections and referendums in municipalities. Residents are invited to consult the Zoning Plan on the website (www.wentworth.ca) to identify the zones concerned. The purpose of such a request is for the resolution containing it to be submitted for approval to the persons qualified to vote in the zone in accordance with article 130 of the Act respecting Land Use Planning and Development;
- 4. To be valid, any request must:
 - Clearly indicate the disposition which is the object and the zone from which it originates;
 - Be received at the Municipal Office, at 175, ch. Louisa, Wentworth, J8H 0C7, or be sent by email to <u>info@wentworth.ca</u> no later than July 23rd, 2024, at 4:30 p.m.
 - Be signed by at least 12 interested persons from the zone of which it originates or by at least the majority of them if the number of interested persons in the zone does not exceed 21;
- 5. Information making it possible to determine which interested persons have the right to sign such a request can be obtained at the Municipal Office, at 175, chemin Louisa, Wentworth, J8H 0C7, or at the e-mail address <u>info@wentworth.ca</u>, to the attention of Natalie Black, General Manager and Clerk-Treasurer, during regular office hours, Monday to Friday 9 am to 4:30 pm;
- 6. Absence of request: if no valid application has been made for the Second Project, it is deemed to have been approved by those eligible to vote;

 Consultation of the Second Draft: the Second Draft can be consulted on the Municipality's website (<u>www.wentworth.ca</u>) and at the Municipal Office, during regular office hours, from Monday to Friday 9 am to 4:30 pm;
