**PUBLIC NOTICE FOR ELIGIBLE VOTERS ON THE ELECTOR'S LIST FOR REFERENDUMS
OF THE MUNICIPALITY OF THE TOWNSHIP OF WENTWORTH**

PUBLIC NOTICE is given as follows:

At a special meeting held on February 22nd 2019, Council adopted "By-Law Number 2019-004, Borrowing By-Law decreeing the acquisition of a vehicle and a \$200 000 loan".

Eligible voters having the right to be on the elector's list for referendums of the Municipality of the Township of Wentworth, may request that this By-Law be submitted to a referendum by signing a register for this purpose. Eligible voters must also enter their name, address and voter qualification.

This register will be available on March 11th 2019, from 9:00 a.m. until 7:00 p.m. at the Municipal Office:

The number of signatures required in order that By-Law 2019-004 be subject to a referendum is 192. The By-Law is deemed approved by eligible voters if said number of signatures is not achieved.

The results of the registration procedure will be announced at 9:00am on March 12th 2019, at the Municipal Office, at the above-mentioned address.

The By-Law may be reviewed at the Municipal Office at the above-mentioned address from Monday to Friday between 9:00 a.m. and 4:30 p.m. or on the Municipal website www.wentworth.ca

In order to be an eligible voter on the elector's list for referendums for the Municipality of the Township of Wentworth, the following conditions must be met:

1. All persons, as of February 22nd 2019, who are not disqualified from voting according to article 524 of the Law on Elections and Referendums in Municipalities and fulfil the following conditions:
 - be domiciled in the territory of the Municipality of the Township of Wentworth and for at least 6 months in Québec and
 - be of full age, a Canadian citizen and not be under curatorship.
2. All non-resident sole owners of an immovable or non-resident sole occupant of a business establishment who are not convicted of an incapacity to vote and fulfil the following conditions:
 - be owner of an immovable or sole occupant of a business establishment situated in the territory of the Municipality of the Township of Wentworth for at least 12 months;
 - in the case of a natural person, be of full age, a Canadian citizen and not be under curatorship.
3. All undivided non-resident co-owners or non-resident co-occupants of a business establishment who are not convicted of an incapacity to vote and fulfil the following conditions:
 - Be an undivided co-owner of an immovable or co-occupant of a business establishment situated in the territory of the Municipality of the Township of Wentworth for at least 12 months;
 - Be designated by proxy signed by the majority of the persons who are co-owners or occupants for at least 12 months, as the person who has the right to sign the register or be on the referendum list. This proxy must be produced before or when signing the register.
4. Legal person:
Be designated by resolution among its members, administrators or employees, a person, as of February 22nd 2019, is a Canadian citizen, of full age, not convicted of incapacity to vote and not under curatorship.

To be eligible to sign the register, an identification card must be presented. The legally accepted identification cards are Driver's Licence or Medical card issued from the Province of Québec, Canadian Passport, Certificate of Indian status or Canadian Forces identification card.
