BY-LAW NUMBER 2022-006

**BY-LAW CONCERNING THE SPEED LIMITS ON THE TERRITORY OF
THE MUNICIPALITY OF THE TOWNSHIP OF WENTWORTH**

WHEREAS the article 626 of the Highway Safety Code (L.R.Q.,c. C-24.2) permits a municipality to regulate by By-Law the minimum and maximum speed limits on its territory;

WHEREAS a Notice of Motion of this By-Law was duly given at the Council meeting held February 7th, 2022 by Councillor Pierre Demers;

WHEREAS a Draft By-Law was duly deposited at the regular meeting of February 7th, 2022;

THEREFORE, it is proposed by Councillor Pierre Demers and decreed that the Municipality of the Township of Wentworth orders and statutes by the present By-Law as follows:

ARTICLE 1

The preamble is an integral part of the present By-Law.

ARTICLE 2

The Municipal Council declares that it has adopted this By-Law, section by section, article by article, paragraph by paragraph, so that if any of these sections should be declared null by a competent court of law, the other sections of the By-Law continue to apply.

ARTICLE 3

No one may drive a road vehicle at a speed:

- a) In excess of 70 Km/h on the roads as specified in Annex A
- b) In excess of 60 Km/h on the roads as specified in Annex A
- c) In excess of 50 Km/h on the roads as specified in Annex A
- d) In excess of 40 Km/h on the roads as specified in Annex A

ARTICLE 4

The proper signs will be installed under the supervision of the Responsible in charge of the Public Works Department

ARTICLE 5

Any person who contravenes to article 3 of the present By-Law commits an infraction and is liable to a fine as per article 516 and 516.1 of the Highway Safety Code;

ARTICLE 6

This By-Law repeals "By-Law Number 2018-004 respecting speed limits in the Municipality of the Township of Wentworth" or any other By-Law enacted for the same purpose.

ARTICLE 7

In case of differences between the French and English versions, the French version prevails.

ARTICLE 8

This By-Law shall enter into force in accordance with the Law.
