**BY-LAW NUMBER 2018-010-01  
MODIFYING PLANNING ADMINISTRATION BY-LAW NUMBER 2018-010**

**WHEREAS** Planning Administration By-Law number 2018-010 of the Municipality of the Township of Wentworth is in effect;

**WHEREAS** a notice of motion was filed on May 2<sup>nd</sup>, 2022 and the Draft By-Law deposited;

**THEREFORE** It is proposed by Councillor \_\_\_\_\_ and  
**RESOLVED**

**THAT** Council adopt the By-Law entitled “By-Law Number 2018-010-01 Modifying Planning Administration By-Law number 2018-010” and it is hereby enacted and decreed as follows:

**ARTICLE 1**

Article 21 “Cost of Permits, Certificates and Other Applications” of Planning Administration By-Law number 2018-010 is amended by:

1. Replacing line 21 of the table by the following:

<b>Types of Intervention</b>	<b>Required Fees</b>
21) Accessory use	AD4 – Short-term rental: \$500 Other use: \$50

2. Adding the following lines under the title “Other Applications”:

<b>Types of Intervention</b>	<b>Required Fees</b>
4) Specific construction, alteration or occupancy proposal for an immovable (SCAOP)	\$1,000

5) Demolition of an immovable subject to the Demolition of Immovables By-Law	\$100

## **ARTICLE 2**

Article 27 "Presentation of the application" of this By-Law is modified by the addition of a 3rd paragraph which reads as follows

"A permit application, including all documents, must be submitted in one (1) paper copy and one (1) digital copy (PDF)".

## **ARTICLE 3**

Article 28 "Minor Project Application Procedure" of this By-Law is modified by replacing, in paragraph 2) of the 2nd paragraph, by the deletion of the words "submitted in triplicate".

## **ARTICLE 4**

Article 31 " Cadastral operation " of this By-Law is modified by the removal of the first paragraph.

## **ARTICLE 5**

Article 35 "Application Request "of this By-Law is modified, in the 1st paragraph, by the replacement of the words" in 3 copies "by the words" in one (1) paper copy and one (1) digital copy (PDF) ".

## **ARTICLE 6**

Article 44 " Application Form: General Content " of this By-Law is modified, in the 1st paragraph, by the insertion of the words " in one (1) paper copy and one (1) digital copy (PDF) " after the words " to the designated official ".

## **ARTICLE 7**

Article 53 " Application Form: Sign, Display and Billboards" of this By-Law is modified, in paragraph 5), by replacing the words "two (2) copies of" by the word "the".

**ARTICLE 8**

The present By-Law comes into force in accordance with the law.
